CONGRESSMAN IKE SKELTON

Congressman Skelton is the leader in the House on defense issues. Congressman Skelton is the Chairman of the House Armed Services Committee. Skelton's district is home to Fort Leonard Wood, Whiteman Air Force Base, and the Missouri National Guard Training Center. Skelton was instrumental in bringing the Army Engineer School to Fort Leonard Wood and the B-2 Stealth bomber to Whiteman. Because the 4th Congressional District is comprised of small towns and farming communities, Skelton looks after the needs of rural America. He is a former chairman of the Small Business Subcommittee on Procurement, Tourism and Rural Development and the Congressional Rural Caucus.

Mr. Skelton, a native of Lexington, was elected to Congress in 1976. He is a graduate of Wentworth Military Academy and the University of Missouri-Columbia, where he received A.B. and LL.B. degrees.

CONGRESSMAN SILVESTRE REYES LUNCHEON SPEAKER

Congressman "Silver" Reyes represents the 16th District of Texas, which includes the City of El Paso. A Veteran of the Vietnam War, he has devoted his life to public service. From 1969 to 1995, Reyes served in the U.S. Border Patrol as an agent, an immigration inspector, an instructor at the Border Patrol Academy, the Assistant Regional Border Patrol Commissioner, and the Sector Chief of the Border Patrol.

Mr. Reyes was elected to Congress in 1996 and has been a leader on national security, veterans, and border issues. In 2006, House Speaker Nancy Pelosi selected Reyes to serve as Chairman of the House Intelligence Committee, which provides Congressional oversight of the 16 agencies that comprise the U.S. intelligence community. He also serves on the House Armed Services Committee and the House Veterans' Affairs Committee.

RDML KATHLEEN DUSSAULT UNITED STATES NAVY

RDML Kathleen Dussault is the Deputy Assistant Secretary of the Navy (Research, Development, and Acquisition). She advises the Navy's senior Acquisition Executive on business matters concerning Navy and Marine Corps programs and provides policy and oversight of the Navy's procurement system. She received her commission from Officer Candidate School in Newport, RI, in 1979, graduated from the University of Virginia in 1977 with a degree in American Government, and graduated from Navy Supply Corps School in 1980. She also has received degrees from the Industrial College of Armed Forces and Columbia Business School.

Rear Admiral Dussault is an expert in military acquisition and financial management and has received the highest levels of certification and joining professional military degrees in these fields. She has served with distinction in the United States and abroad and has received numerous decorations for her service.
